## **Availability, Attendance Commitment and Policy**

As a Sub-contractor of Enque Logistics, it is imperative that we all abide by the alloted schedules, wave systems, On-Call schedule, and weekend Schedule alloted as any attendance issues impact the business with our contractor INTELCOM EXPRESS. Work that i not covered causes the loss of extended routes from our contract with INTELCOM EXPRESS, therefore it is extremely important that it is not impacted by attendance issues. Please read the list of requirements Enque Logistics expects of its sub-contractors/agents and acknowledge these policies by signing below.

- Sub-contractors/agents are required to arrive on time for alloted schedules, wave schedules, and weekend schedules.
- When a Sub-contractor is OnCall, you are required to pick up a call from the manager to assist the agent/s who need help between the hours of 5:00am-8:00pm.
- There will be \$100 fee charged for any late call-ins (if no notice is given within 2 days of missing work) and no call-no show.
- -I understand that I am required to be available for work at least 1 weekend day of the week. Designated routes require an agent to cover the route 7 days a week unless coverage is available (Part-time, On call, new hires).
- A \$100 incentive will then be given to the person that takes on the work for the person that calls in/does not show up to work.
- We do understand that there are extenuating situations that arise and do affect attendance, however, we are a business that has to still complete work extended by the contractor whether or not an agent/sub-contractor comes in or misses work, so there will be NO EXCEPTIONS to this rule, if you miss your scheduled time of work, your workload will be reassigned, you will be charged \$100 which will be given to agent covering your workload.
- 2 weeks notice is required to quit your role, if 2 week notice is not given, your remaining 2 weeks invoice payout will be directed to cover expenses to train and replace the new driver replacing you. It is imperative that you give notice in written form well ahead to allow Engue Logistics to replace you.

I acknowledge that I understand the above policies and requirements for my attendance. I understand that Enque logistics reserves the right to charge \$100 non attendance and that I am required to give 2 weeks notice when seeking to terminate my employment. I understand that I am required to arrive on time and to answer my phone when On-Call. Failure to maintain these requirements and policies will result in partial loss of Invoice payout and or termination if behavior continues to happen.
